Facility Membership Information:

If you are a Member at Summit or Washington, there is no additional fee. If you will swim at Summit, and not a member, you will pay the \$35 facility fee as part of your Registration. If you will swim at Washington, and are not a member, you will need a temporary membership. Rates start at \$10 per month with **NO** contract or initiation fee. Please remind Washington that you are swimming for SUSA - so that the initiation fee will be waived!

Team Swim Suit Information:

If your TEAM suit from last summer (blue/black TYR suit) is in good condition, you may use the same one this season. If you need to purchase a new TEAM suit, go to the Summit ProShop (1535 S. 1450 E.) – Call first!!! (628-5000). The new suits this year are different from last year. The reason is two-fold: the sizing and wear of the suits from last year was confusing, and we are now using the same suits as the year-round team. Summit has again passed on their bulk discount to SUSA members – \$35 for female suits, and \$25 for male jammers (knee-length competition suits).
